BCTA's *PhoneSave* Program offers long distance service on the Telus network, 24 hours a day / 7 days a week. There are no set-up fees or surcharges. **Service on direct dialed calls, faxes and toll-free calls is 4 cents per minute anywhere in North America.**

Calling Card Terms and Conditions:

1. Use of the Association Member Calling Card (AMCC) constitutes acceptance of the following Terms and Conditions: (a) The AMCC is the property of the BC Trucking Association (BCTA) *PhoneSave* Program and must be returned upon request; (b) BCTA *PhoneSave* Program reserves the right to revoke an AMCC for fraudulent or suspected fraudulent use, or if the Cardholder alters his or her relationship with BCTA or withdraws from the *PhoneSave* Program; (c) The AMCC has no expiry date and is valid as long as the user is a member of the *PhoneSave* Program. Use of AMCC after service is discontinued is illegal and constitutes fraud; (d) Rates associated with the use of the AMCC are set by the *PhoneSave* Program. These rates are subject to periodic revision and may be changed without notice; (e) The business owner or other person signing this Consent Form agrees to pay all charges incurred through the use of the AMCC; (f) The AMCC card is for use in North America only; (g) The AMCC is not transferable to another telephone number or person. If a Cardholder terminates employment with the employer who has issued them the card, the card must be returned to the employer or to *PhoneSave* Program, and the employer must call 604-888-5319 or 1-800-565-2282 immediately to have the card number removed from the validation databases. The billed party is responsible for all charges incurred by the use of the AMCC by previous employee Cardholders until the change in the employees' status has been reported; (h) If the AMCC is lost, stolen, or the number becomes known to or used by unauthorized persons, please call 604-888-5319 or 1-800-565-2282 immediately to prevent fraudulent use. (i) The billed party is responsible for all charges incurred through the use of the AMCC until such loss, theft or unauthorized use has been reported.
