

CleanBC Heavy-duty Vehicle Efficiency Program Incentive Rebates

Please read the instructions below and ensure all required materials are included before submitting your application.

1. Completion of all fields on the form is mandatory.
2. Applications are to be submitted in person, by mail at the British Columbia Trucking Association (BCTA) office at 100 - 20111 93A Avenue, Langley, BC, V1M 4A9 or by e-mail to CleanBC@BCTrucking.com. Your application has not been received until you receive email confirmation. If you do not receive an email confirmation within 2 business days, please contact BCTA Operations Coordinator, Jennifer Cameron, at 604-888-5319.
3. The application must include:
 - A current copy of your company's National Safety Code (NSC) carrier profile demonstrating a "satisfactory" rating;
 - BC Certificate of Incorporation; and
 - Documentation that qualifying the equipment/device has been purchased and installed (e.g., Bill of Sale, insurance documents, lease agreements).
4. BCTA will only review fully completed applications from companies that meet the eligibility requirements of the CleanBC Heavy-duty Vehicle Efficiency Program, including, but not limited to, the following:
 - At least one company representative must take and pass the CleanBC Heavy-duty Vehicle Efficiency Program Course within the program year (August 12, 2022 to August 31, 2023) prior applying and prior to taking possession of fuel-saving equipment;
 - The incentives must be for eligible equipment to be installed on a heavy-duty vehicle (or vehicles) with a gross vehicle weight (GVW) greater than 11,794 kg and operated in BC;
 - All qualifying equipment being applied for, must be purchased and installed in BC;
 - The company must conduct business in BC; and
 - The company must have at least one terminal in BC.

Note: Fuel saving equipment that is purchased and taken possession of prior to the Program year (August 12, 2022) and prior to a company delegate attending and passing the free Program Course is NOT ELIGIBLE for Program rebates.

5. BCTA will use third-party sources to verify models of qualifying equipment in each application and the estimated fuel savings associated with these models (for example, see [this link](#)).
6. Program Incentive Rebate is not guaranteed and is subject to fund availability (i.e., first come first served as per the Program Guide).
